Wytze Riemersma and Marco Balk have been managing TCM Investment Funds since the start in 2008. Wytze Riemersma is CEO of Trustus Capital Management B.V. (Trustus). Trustus is the Investment Manager of TCM. Marco Balk is Head of TCM Investment Funds.

The funds are co-managed, where both managers are responsible for the 5 step investment process. The managers are assisted by an analyst. This is used next to the TCM Quantitative and Qualitative selection model. The fund management is responsible for the investment decisions. Daily risk checks are made if the investment decisions comply with the prospectus and risk management rules.

The fund managers discuss the performance of the fund and its individual shares on a daily basis. Decisions to buy or sell are only made if both managers agree on it and after a Quantitative en Qualitative check has been performed. These decisions are registered in the Meeting Minutes.

Wytze Riemersma and Marco Balk are both shareholders of one or more sub funds of TCM. Wytze Riemersma and Marco Balk are both shareholders of Trustus, the Investment Manager of TCM Investment Funds.
